

#### Attachment #2 – Junior Warden Report 2023

This year really flew by. Seems like yesterday Lester just started the weekly grass cutting and now his crew is collecting all the fallen leaves.

As I walk around St. Paul's I always see someone doing something; for example, you can see people tending gardens, changing light ballast, painting, hauling stuff to the dump, making various repairs. etc. etc. We're a very active church community

Here are some highlights of projects from this past year:

Back in April the elevator was shut down for over a week due to a what seemed like a mysterious problem the techs individually couldn't solve but as a team they came up with the solution. A power supply unit failed.

We complied with county regulations and installed a grease trap in Donaldson Hall Kitchen.

We're now in the middle of our brick walkway repair project. The area near the prayer garden is completed so now we're focusing on the walkways at the Liberty street Church entrance. This area is scheduled for a spring completion.

I'm sorry to say our three, now minor, rain leaks could not be totally solved this year so they will be added to next year's 2024 agenda.

The Rectory had some plumbing and electrical repairs, plus we upgraded a long section of gutter. The size was increased to handle the amount of water flow.

There were two minor fender bender accidents in the parking lot. The people are fine but the maple tree and the light pole did not survive.

We now have two detailed proposals for the Rectory's exterior renovation project.

Both of our geothermal pumps are leaking and we're in the process of having them repaired.

In November we hired Schuman Janitorial. They will be providing and managing the new house-keeping crew. Welcome Aboard!

I would like to thank the Vestry, property committee, and the leadership team, for their support and help. And a special "Thank You" to Michele for her 20 years of dedication.


Thanks also to the Transition Committee led by Bob Ozinga as they work toward finding a new Rector.

Our Parish Administrator, Michele Miller also deserves recognition for her dedication and outstanding performance in managing a multitude of daily issues.

Our Jr. Warden, Charlie Ackermann has done a fantastic job addressing a multitude of ongoing projects to maintain our Church building and Rectory and I will be providing a list of those shortly.

Finally, my thanks to all Parishioners, especially those who lead St. Paul's numerous ministries, for their commitment and support of St. Paul's and dedication to our ministries and especially to those who reach out to our community.



#### Jr. Warden's 2024 Annual Report

#### **Completed projects**

There were several phases in the project that changed the appearance of our Church's liberty St. entrance this year. First, we removed the two diseased trees. Second, the main entry walkway needed to be replaced. In keeping the same design, they installed an all-new brick and blue stone walkway. Then to complete the job we added new shrubs and flower beds.

Our two geothermal pumps were in need of repair and replacement. In order to keep our HVAC system running they could only work on one pump at a time. At the end of the two-month project they rebuilt two pumps and replaced one electric motor.

Due to the inadequate services from our HVAC service company, we solicited bids from several companies. During the process we discovered the need to expand the search to include an HVAC computer control company as well. As a result, we hired Modern Controls Company who provides both services.

Schuman Janitorial service notified us that they will be raising their service fees in January 2025 so we are in the process of soliciting bids to see what the current market value dictates. We may need to change companies.

Numerous smaller projects that were completed this past year including **1**, The Installation of a new garbage disposal, **2**, Replaced the Liberty St. "St. Paul's" sign and restored the Commerce St. "St. Paul's" sign, **3**, Replaced all the light bulbs in the church and installed new LED lights in the Richardson room, **4**, Re-secured and checked all pews in the church. **5**, Completed all required annual inspections.

#### Projects that have been started this year but will not be completed until 2025.

1. To complete upgrades to our security alarm and entry system.

2. Surveying the conditions of the plumbing pipes in the crawl spaces under the church, and replacing as needed.

3. Due to a reoccurring leak Stabil Solutions is scheduled to return for warranty work to reseal the basement hallway wall.

4. The Rectory includes repairing the exterior main water line, various interior repairs, and painting.

5. HVAC – Catching up on needed repairs to items that were missed from our previous contractor.





#### St. Pauls Episcopal Church, Centreville Annual Report of the Treasurer 2024

#### **OPERATING FUND**

The Operating Fund has ended 2024 in a positive position. Certain budgeted expenses that were not realized after Reverend Friel's retirement offset a shortfall in revenue from budget predictions. The year ended with a \$10,695 surplus which will be carried forward.

Pledges to the Operating Fund dropped 9% for 2025 to \$268,085 from 56 households. It is our hope that there will be an increase in unpledged gifts to make up that difference. Expenses incurred in the search for a new rector until it is completed will be coming from the Operating Fund. That is in addition to the salaries of our organist and parish administrator who is also our assistant treasurer. It also covers the expenses associated with the daily operations of the Parish such as utilities, administrative costs, live streaming of services, cleaning and security, insurance and payroll taxes. When parishioners make a pledge to St. Paul's during the annual stewardship campaign, the fulfillment of that pledge covers its operating costs. As its title describes, without the Operating Fund, the Parish could not operate.

#### **BUILDING FUND**

This year's Building Fund ended the year in a positive position, as well. Due to the generous contributions from the parish earmarked for the Building Fund, we will have \$9,261 to carry forward for next year's projects.

The Building Fund, or Capital Fund as it can be called, is used to cover all maintenance expenses for the church, rectory and all our grounds. Those expenses are everything from lawn mowing to maintenance contracts to repairs on our elevator. It is also used to make any improvements to our buildings and grounds of a capital nature.

Revenues that go into the Building Fund come from the rental of our parking lot to Wye River Upper School and the many generous gifts from our parishioners. When parishioners make a gift earmarked for the Building Fund, those gifts are used to pay buildings and grounds expenses only. Our buildings have a long, valued history and our Parish is committed to keeping them in the best condition possible. Our grounds are part of the beauty of our property, and used every day. They, too, are kept in the best condition possible, thanks to the many designated gifts to the Building Fund.

#### **INVESTMENT FUNDS**

The endowment funds of St. Paul's ended the year on a positive swing, as well. They increased an average of 8.7%. The vestry has set a withdrawal of 5% for 2025 to use as each fund is directed.

# SUMMARY REPORT

# The Transition and Search Committee 26 January 2025

This is a summary report to the St. Paul's Annual Parish Meeting of the Transition and Search Committee ("the Committee") during 2024. Upon the date of this report, the Committee's work is ongoing into 2025.

At the St. Paul's Vestry meeting of April 23, 2024 our rector of over ten years, the Rev. Mary P. Friel, announced her departure, effective October 20 of last year. Her announcement surprised the Vestry and, subsequently, the whole congregation.

The Vestry met again on May 28 and, after discussion, commissioned the St. Paul's "Transition and Search Committee", with Bob Ozinga as its chair, to help guide the parish through a prayerful reflection on the parish's mission and its hopes for the next stage in its life. The Committee also must compose a compelling and clear Parish Profile, which will precede the search for a new St. Paul's rector.

The rector search process, while carefully organized and attentive to many organizational details, differs from a corporate search process in that it is conducted at all times in a spirit of prayer and in the perspective of the question "What is God's call to us as a parish, at this time, in this place?" It is also meant to be a time of spiritual and communal growth for us as a congregation, and opportunity for us to strengthen the laity of the parish.

By June, the Committee had been formed and 17 dedicated parishioners had been enlisted as members of three work "teams":

- A Transition Team to oversee the many administrative changes and challenges the parish will face during this period. Co-Chair Tom Andrews heads this team.
- A Communications Team to develop crucial documents, surveys and profiles of our parish. Co-Chair Chris Pupke heads this team.
- A Search Team to conduct the actual search process, interview interested candidates, and provide for supply or interim clergy during the search. Co-Chair Mark Freestate heads this team.

The Committee, through its Chair and Co-Chairs, provides monthly updates and reports to the Vestry. On December 17, they joined the Vestry in meeting with Bishop of the Diocese of Easton Santosh Marray to develop two-way communications between the diocese and St. Paul's during this period of change.

A summary of each team's activities is below:

## THE TRANSITION TEAM

The Transition Team has assumed certain duties to support the Senior Warden, the Parish Administrator, and the Treasurer in implementing day-to-day administrative tasks previously performed by the rector. Tasks include items such as proof-reading bulletins and other parish publications, check-signing, timesheet approval, calendar planning, and many other tasks to help the parish function efficiently going forward.

The Transition Team's Co-Chair completed the rector's portion of the 2024 Parochial Report.

The Transition Team prepared and is presenting a report and recommendation to the Vestry regarding St. Paul's implementation of the Safe Church/Safe Communities Program adopted by the National Church and the Diocese of Easton.

Transition Team members include Co-Chair Tom Andrews; Dot Abbott; Barb Ackermann; Gail Brown and Sharon Burak.

#### THE COMMUNICATIONS TEAM

The Communications Team is charged, among other things, with conducting the Parish Survey, developing the Parish Profile, refreshing the parish website and coordinating the weekly transition prayers.

The Parish Survey was completed in September 2024 by the Holy Cow Consulting organization. St. Paul's congregation responded in great numbers to this Survey. In October the whole Committee and the Vestry participated in a review of the Survey results with Holy Cow staff. The results of the Survey were shared with the congregation at a meeting following Sunday worship on December 8<sup>th</sup>.

The Survey helped inform the Parish Profile. The narrative for the Profile is completed, with assistance from a professional editor. The draft narrative has been reviewed by the entire Committee. In the near future, a professional graphic designer will make it visually appealing. Completion is slated for early in 2025.

Communications Team members include Co-Chair Chris Pupke; Carolyn Carney; Patricia Jamison; and Jack Shaum.

#### THE SEARCH TEAM

The Search Team has been busy engaging supply priests for our Sunday and Wednesday services since Rev. Friel's departure In October. Our Team is delighted to have the Rev. Mark Delcuze serving as our long-term Supply Priest.

Following the publication of the Parish Profile, the Search Team will be fielding applications and interviewing appropriate candidates for rector. They will refer a final candidate to the Vestry for consideration and approval. The Team looks forward to a robust response to our request for applicants.
